WHAT'S INCLUDED

- **Seattle Business Address:** Use our Seattle, WA address on all Washington Secretary of State filings to keep your home or office address off the public record.
- **Same-Day Document Scanning:** Anything served on your business gets scanned the day it arrives and sent to you before the end of the business day.
- **Encrypted Electronic Forwarding:** Legal documents forwarded to you as encrypted PDF, accessible through your client portal and email of choice.
- **Annual Report Reminders:** We track your WA Secretary of State annual report due date and remind you well before the deadline so you never lose good standing.
- **WA DOR & B&O Reminders:** Upcoming Washington Department of Revenue filings and city business license renewals flagged before they go late.

ALREADY HAVE A REGISTERED AGENT?

MOVING TO LAUNCH FROM ANOTHER PROVIDER?

Switching registered agents takes about 10 minutes of your time and costs you nothing in filing fees. We prepare and file the change with the state, confirm acceptance, and take over your legal mail with no gap in coverage.

HOW TO SWITCH IN 3 STEPS

STEP 01

YOU Sign Up

Sign up online or call us. We collect your entity name, UBI number, and current registered agent details.

About 10 minutes



STEP 02

LAUNCH INDUSTRIES We File the Change

We prepare and file the Statement of Change of Registered Agent with the WA Secretary of State for you.

Filed within 48 hours



STEP 03

WA SECRETARY OF STATE Done. We Take Over

The state updates your record. We confirm acceptance, store the filing in your portal, and begin receiving mail on your behalf.

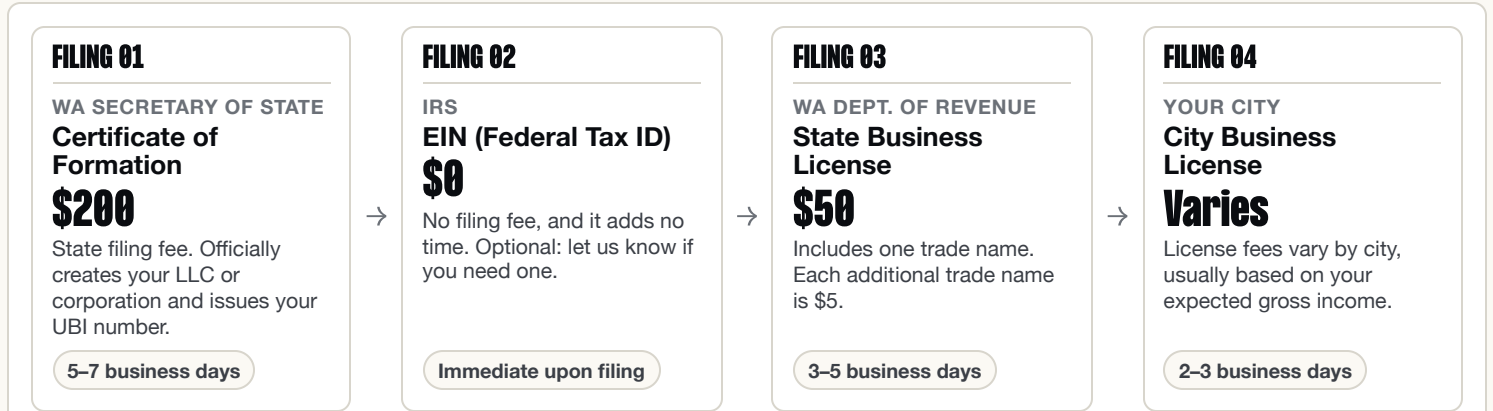

SETTING UP YOUR BUSINESS FOR THE FIRST TIME?

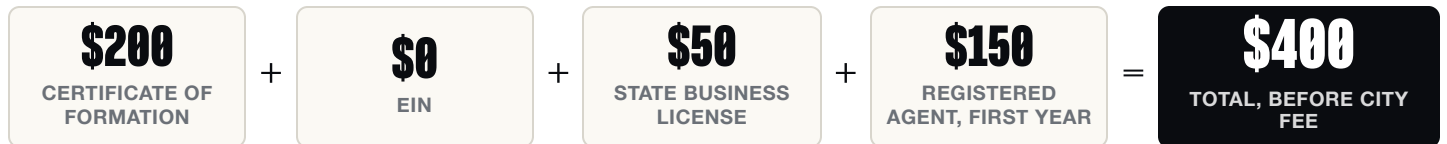
THE FILING SEQUENCE – WE HANDLE EVERY FILING

Forming a new Washington business along with your Registered Agent service? You fill out one short intake form, and Launch Industries prepares, files, and tracks every application from there. We confirm each approval as it lands and store everything in your client portal.



City fee example (Seattle): about \$75 when annual gross income is up to \$20K, and about \$150 for income above that, up to \$500K. We confirm your city's exact fee before filing. Most cities license through the state DOR application, but some, including Auburn, Bellevue, Des Moines, Everett, Kent, Lake Forest Park, Poulsbo, Renton, Seattle, Shoreline, and Tacoma, use a separate filing process through the FileLocal portal. We handle whichever process your city requires.

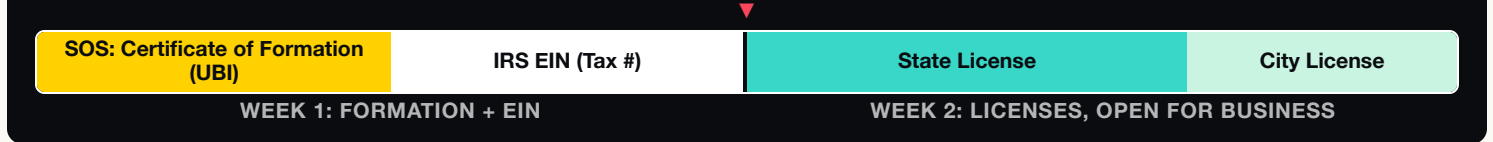
YOUR COST TO LAUNCH



Total excludes your city license fee, which varies by city and expected income.

START TO FINISH: ABOUT 2 WEEKS

RECOMMENDED: OPEN YOUR BUSINESS BANK ACCOUNT



One intake form is all we need from you. Launch Industries does all of the work of the filings: preparing each application, submitting it to the right agency in the right order, and tracking it through approval. Government filing fees above are paid to each agency.
